ORDER DECLARING IMPASSE AND APPOINTING A MEDIATOR

On December 15, 2008, the UNIVERSITY OF HAWAII PROFESSIONAL ASSEMBLY (UHPA), by and through its counsel, filed a notice with the Hawaii Labor Relations Board (Board) pursuant to Hawaii Revised Statutes (HRS) § 89-11(c)(1) stating that an impasse exists with respect to negotiations for bargaining unit 07. The UHPA also requested the Board appoint a mediator or mediators to assist the parties in a voluntary resolution of the impasse.


Pursuant to HRS § 89-11(c), the Board hereby declares that an impasse exists in negotiations for bargaining unit 07 as of December 15, 2008.

Pursuant to HRS § 89-11(d)(1) and UHPA's request, the Board hereby appoints Federal Mediator Carol Catanzariti to assist the parties in the voluntary resolution of their dispute.
